You are hereby notified of the following changes to the above mentioned bid:

Delete, Paragraph 2.2.1, Pg. 11 and replace with the following:

In Section 5, "Pricing," bidder shall provide a discount or Mark-up for the following manufacturers" Dumor (Item 5.2), Kompan (Item 5.4), Landscape Structure (Item 5.5), American Swing (5.8). Discount or Mark-up MUST remain firm for the life of this contract.

If providing a discount the list may be updated in the event of price changes in the published price lists established by the Manufacturer. The Manufacturer's list price shall be the current published price list at the time of the bid opening. Discount will remain firm for the entire period of the contract to include any subsequent renewal and/or extension period(s).

Vendor must submit a copy of original supplier's invoice with their invoice to the City. In no case shall parts cost exceed the actual cost from the supplier + the vendor mark-up.
